
For those of us who live in rural areas, this Liberal budget has some real implications. Don't forget, these tax hikes are on top of the tax credits the Liberals already took away from families since their last budget, such as the Children's Fitness Tax Credit, Children's Arts Tax Credit, and income splitting for families. Further, students can no longer claim the tuition and textbook tax credits brought in by the previous Conservative government to help with their education costs.

> If you're a business owner, there's nothing in this Liberal budget for you, even though Saskatchewan's businesses help to make up the backbone of our Canadian economy. In fact, the Liberals have been doing a lot to make small businesses uncompetitive, by forcing provinces to buy into their carbon tax Justin Trudeau has also cancelled the scheduled reduction of the small business tax rate, on top of his elimination of the Hiring Credit for Small Business and his payroll tax hike for employers.

It is obvious that Justin Trudeau and his allocated in the budget - the Liberals have no respect for the majority of which will be going to taxpayer. If they did, they wouldn't have Canada's largest cities. Overall, this broken their election promise of a \$10



billion deficit over two years by gifting Canadians with a \$29 billion deficit for this year.

Justin Trudeau's priorities are not the hardworking priorities of Saskatchewanians.







## Budget 2017 Does Nothing to Support Farmers

Budget 2017 does nothing to support hardworking Canadian farmers. There is no new money for the business risk management - a priority for agricultural producers. Farmers and fishermen will also face higher premiums because of changes to the tax credit insurance companies receive for supplying insurance.

Budget 2017 proposes to provide clean technology funding to three departments -Agriculture and Agri-Food Canada, Natural Resources Canada and Fisheries and Oceans Canada.

This money is to go to academics, industry and research labs, but will not be available to producers. New money announced for science and innovation is now focused on climate change, and soil and water conservation; again without any dollars going into the hands of



farmers for new business risk management approaches.

The most detrimental part of the 2017 Budget to agriculture producers is a plan to eliminate the cheque deferral for grain income. This was a program set up to help farmers manage inventories and manage income tax.

For example, if a train was to show up in Saskatoon in mid-December, grain producers would have the option of deferring the cheque for their grain delivery to the next fiscal year if their taxes had already been completed.

This would allow for both proper tax planning for the grain producer and allow for grain cars to be filled in order to keep grain moving on the Prairies. This change proposed by the Liberals will be a huge new tax expense for grain producers.

Budget 2017 commits to "Accelerating the Growth of High-Impact Firms" to replace conventional chemical pesticides.

Concerns have been expressed over the process used by the Health Minister to ban neonicotinoid chemicals. Hopefully this initiative does not establish a policy process that sets environmental politics ahead of real science.

The government's proposal to provide \$80 million on a cash basis over five years to replace the Sidney Centre for Plant Health in British Columbia does not make it clear how the money will be spent on the new plant health and how will this will help farmers.

Further, Budget 2017's promise to invest \$500 million to support the expansion of broadband networks in rural Canada will do little to support rural infrastructure, including roads and bridges.

## Working For Our Constituency as Opposition Critic for Canada/US Relations

I was honored to travel to Washington with our Leader, Rona Ambrose, to meet with American legislators prior to Donald Trump's inauguration as the forty-fifth president of the United States. The Trump Team released its 100-day plan back in October, so Canada and the world have had an idea of what to expect during the first days of the new Administration.

Comments from Trump's Commerce Secretary confirmed that the North American Free Trade Agreement is one of the first items on President Trump's agenda. As NAFTA is Canada's most important free trade agreement, the Liberal government must have a strategy in place for ensuring that Canada's interests are protected if and when future negotiations occur.

In short, Justin Trudeau and his Liberals must make our relationship with the United States their number one foreign policy and international trade priority.

Conservatives have been saying all along that the Liberal government must stop governing in the past and start reaching out to the Trump team to defend Canadian jobs. I am therefore pleased that the Prime Minister heeded this advice and sent his senior advisors to meet with Trump's transition team to discuss the future of NAFTA.

But just taking meetings is not enough -Canadians expect to see results from the Liberal Government. We hope to see results that include the protection of almost 400,000 jobs from a new softwood lumber agreement, new jobs for Canadian oil and gas sector workers from an agreement to build the Keystone XL pipeline, and the continuation of our stable trading relationship through the preservation of the mutually-beneficial North American Free Trade Agreement.

The Liberal government must also work to engage Congress, like Ms. Ambrose and myself have been doing; and harness cross-border associations such as the Canadian-American Business Council and the Pacific Northwest Economic Region, to apprise American decision makers on the the Canada-U.S. importance relationship to both Canada's and America's prosperity.



They need to know that almost \$2 billion in trade crosses our shared border every day and that nine million American jobs depend on trade with Canada.

Recognizing the intention of the new Trump Administration to enhance U.S. domestic competitiveness by lowering U.S. corporate and income taxes, Justin Trudeau must also take action here at home to ensure that our Canadian businesses can maintain their own competitiveness in the North American I will also continue to work to hold market.

Specifically, it is imperative that this Liberal government give up on its carbon tax scheme and other taxraising measures which are putting Canadian companies at a competitive disadvantage internationally.

### Justin Trudeau is withholding information from Canadians

Once again, the Liberal Carbon Tax is making headlines, and again it is for shameful reasons.

Yet what he received back from the government was a redacted document which had the household cost of the tax blacked out.

For a Prime Minister who ran on a platform that states that "the government and its information should be open by default," and that "data paid for by Canadians belongs to Canadians", this is shameful behaviour. The reality of the Liberals' disgraceful action is that the household cost of the carbon tax must be high; otherwise they wouldn't care if Canadians knew. For purely political reasons, Justin Trudeau is choosing to Grain companies will also have to pay less to farmers to withhold this information from Canadians.

As the Canadian Taxpayers Federation's Todd MacKay recently noted, "A Toyota Prius cannot pull an air seeder."


